

F-1 Student Financial Statement IEP ESL Pathway Degree *(Select the program you are applying for)*

Instructions: As a student, it is your responsibility to demonstrate that you have sufficient financial support available to cover all educational and living expenses while you are studying at NOVA. Completing an Associate degree may take up to 3 years.

If you have a sponsor who will be funding your studies, you must provide their bank statement(s) showing the annual estimated cost for one year. If you are self funding your studies, you will need to show the total cost for three years in your bank statement(s) for Degree applicants and one year for IEP or ESL Pathway applicants.

All bank statements must be in English or include a certified English translation that clearly shows the account owner’s name, statement date, balance and type of currency along with the original statement. NOVA reserves the right to request clarification or additional information related to any bank statements submitted. You will need copies of these documents when you apply for your F-1 visa.

* To maintain F1 status, the student must remain enrolled in at least 12 credits in both the fall and spring semesters. Tuition could be higher if student enrolls in more than 12 credits each semester.

** Estimated living expenses are for nine months. Students who intend to remain in the US for summer break should plan for additional living expenses.

Housing: NOVA does not offer housing or meal plans. You will be responsible for making your own living arrangements. Living expenses are estimated.

Dependents: If you will be accompanied by dependents (spouse and/or children) you must add \$6,898 per year for a spouse and \$3,450 for each child. Copy of birth certificate for children unmarried and under 21 and/or marriage certificate for spouse must also be provided in English.

SPONSOR'S AFFIDAVIT OF SUPPORT

A sponsor may be a parent, family member, or another person who will provide financial support to the student. It is not necessary that a financial sponsor live in the U.S. If there is more than one sponsor, each sponsor must complete a separate form. One financial sponsor may provide complete or partial support for the student, but the student's total financial support must equal or exceed the total estimated costs noted on page 1.

To the financial sponsor : In addition to signing this document, you must provide a **bank statement** that includes your name, the name of your bank, the statement date, amount of the available funds and type of currency. The bank statement must be in English or include a certified English translation and clearly show the information required.

The statement must be dated no more than one month before the date of application submission.

This evidence is required to complete an official US government form on which the school official is confirming that financial support is available. Therefore, Northern Virginia Community College reserves the right to request additional information or clarification regarding documents being provided.
