Efficient Scheduling through Space Optimization at the Medical Education Campus: Fall 2019

This Report presents seat utilization rates by discipline and course at the Medical Education Campus for Fall 2019. The seat utilization rate for each section of a course is calculated by dividing the number of students enrolled in the section by the room capacity, or the number of seats that fit in the classroom. Data were unduplicated by class number. The following types of classes/sections have been excluded: cancelled classes, NOVA Online sections, off-campus venues sections, auditoriums or classroom with capacity over 60, zero-credit labs, applied music courses (private lessons), music ensemble courses, and courses designated as internships, on-the-job training, or independent study.

Tables are divided by discipline and sorted by course number in descending order of the seat utilization rate for the sections. Other information by section includes: component (type of class, e.g., lecture, credit-bearing lab, etc.), room number, meeting days, start and end time, and number of empty seats. The utilization rate is color coded as follows:

0-32 percent - low utilization - Red

33-65 percent - medium utilization - Blue

Over 66 percent – high utilization – Green
