



NOVA Annual Enrollment: FTES





NOVA Dual Enrollment: FTES





Indicator 17. NOVA Dual Enrollment as Percentage of Total Enrollment: 2014-15 through 2019-20



NOVA Dual Enrollment as Percentage of Total Enrollment: FTES



NOVA Percentage of Transfer Program Graduates Who Transferred



NOVA Graduation Rates for Fall Cohorts




Indicator 20. NOVA Retention Rates by Enrollment Status: Fall 2015 Cohort through Fall 2019 Cohort


