## Contract Dual Enrollment Savings to Parents by Area Public School System: Spring 2022 through Fall 2023

This report presents the savings to parents of Northern Virginia Community College (NOVA) contract dual enrollment students who were enrolled in NOVA courses in the Spring 2022 through Fall 2023 semesters. The student data in this report are presented by the region's public school system. Contract dual enrollment students (i.e., students who take NOVA classes at their high school with a qualified high school teacher) do not pay tuition for their dual enrollment courses. Table 1 presents the number and percentage of NOVA contract dual enrollment students who were enrolled in NOVA courses from Spring 2022 through Fall 2023.

The savings were calculated by multiplying the number of credits in Table 2 by the total tuition and fees per credit given in Table 3.

Table 5 provides the average savings per student for NOVA contract dual enrollment students who were enrolled in NOVA courses from Spring 2022 through Fall 2023. These savings were calculated by dividing the number of credits earned in Table 2 by the number of students in Table 1 and multiplying the quotient by the total tuition and fees per credit given in Table 3. Note that the data provided in Table 5 should be interpreted with caution since these amounts do not reflect the actual apportioning of savings per student.
