


Transient Student Enrollment in Summer Sessions: Summer 2014 through Summer 2016

A transient, or visiting, student is a student enrolled in Northern Virginia Community College (NOVA) courses while maintaining primary enrollment at another institution. Often, transient students are enrolled full-time in a four-year college or university but choose to take advantage of NOVA course offerings during the Summer semester. This Research Brief presents enrollment trends of transient students from Summer 2014 through Summer 2016.

Finding #1: Transient student course enrollment in Summer sessions has remained stable, while total course enrollment in Summer sessions declined 11 percent over the past three years.

Overall, Summer enrollment declined over the past three years, from 38,083 course enrollments in Summer 2014 to 33,961 course enrollments in Summer 2016 (an 11 percent decrease). Transient student course enrollment remained stable during this time, while non-transient student course enrollment declined by an average of 6 percent every year (Figure 1).





Finding #2: Transient students enrolled most often in the dynamic session and least often in 8-week or 12-week sessions.

Dynamic sessions have a variable duration and accounted for 51 percent of all transient student course enrollments in Summer 2016, an increase from 43 percent in Summer 2014.¹ Other popular Summer sessions for transient students were both 6-week sessions. However, transient student enrollment in




Figure 2. Transient Student Course Enrollment in Summer by Session: Summer 2014 through Summer 2016

courses in the 1st 6-week session declined 23 percent as enrollment in dynamic courses increased 19 percent over this time period (Figure 2).

Comparatively fewer transient students enrolled in courses in the 12-week and 1st 8-week Summer sessions, and few to no transient students enrolled in courses in the 2nd 8-week Summer session (Figure 2). This suggests transient students may have scheduling conflicts with longer sessions, possibly due to NOVA Summer session schedules conflicting with the beginning of the Fall semester at their primary institution.

Note: The duplicated headcount, or course enrollment total, is the total student enrollment across all courses; a student taking more than one course would be counted for every course they were enrolled in. The unduplicated headcount is the total number of *unique* students enrolled in Summer courses; each student is counted one time regardless of how many courses they were enrolled in.
