Graduation, Transfer-Out, and Retention Rates: NOVA's Student Right-to-Know Information

This Research Brief presents data for Northern Virginia Community College in compliance with the federal Student Right-to-Know Act. The Act requires NOVA to disclose graduation, transfer-out, and retention rates to current and prospective students. The source of this data is the U.S. Department of Education, National Center for Education Statistics, Integrated Postsecondary Education Data System (IPEDS). Based on the data made available through IPEDS, graduation and transfer-out rates are disaggregated by gender and race/ethnicity, while Fall-to-Fall retention rates are disaggregated by enrollment status (full- or part-time).

Graduation Rates

Table 1 presents graduation rates for first-time, full-time degree- or certificate-seeking students who graduated within 150 percent of normal time to completion. Graduation rates are presented for the Fall 2010 through Fall 2012 cohorts.

Transfer-Out Rates

Table 2 presents transfer-out rates for first-time, full-time degree- or certificate-seeking students who transferred out of NOVA within 150 percent of normal time to completion without first earning a degree. Transfer-out rates are presented for the Fall 2010 through Fall 2012 cohorts.
