Point-in-Time Comparison (August 8, 2016 versus August 10, 2015) of FTES by Subgroups: Alexandria Campus

This Research Brief compares FTES enrollment at Alexandria Campus disaggregated by student demographic subgroups in Fall 2015 and Fall 2016. The data in this document provide a point-in-time comparison: Monday, August 8, 2016 compared to Monday, August 10, 2015.

At the Alexandria Campus, FTES declined by 11 percent (-440 FTES) from Fall 2015 to Fall 2016 as of August 8, 2016 (Table 1). The following is a summary of the trends among different student demographic sub-groups.

## Age

- Among traditional age students (18 to 21 years old), FTES at the Alexandria Campus decreased by 7 percent (-108 FTES).
- Alexandria also saw a similar loss of FTES (-107 FTES, -16 percent) among students ages 25 to 29.
- FTES among the following large age groups also showed a decrease equal to or greater than the overall campus decrease of 11 percent:
  - 22-24: -14 percent (-85 FTES)
  - o 30-44: -11 percent (-78 FTES)
  - o 45-59: -28 percent (-54 FTES)

### Gender

 The decline in FTES among female students (-15 percent, -313 FTES) at the Alexandria Campus was more than double that of male students (-7 percent, -121 FTES).

#### **Student Type**

- FTES enrollment of returning students decreased by 12 percent (-371 FTES).
- FTES enrollment of first-time students decreased by 11 percent (-59 FTES).

#### Race/Ethnicity

 The FTES enrollment of Hispanic students declined by 14 percent (-91 FTES) from Fall 2015 to Fall 2016.

- The other large racial/ethnic groups showed the following declines in FTES:
  - White Students: -12 percent (-128 FTES)
  - Black Students: -12 percent (-124 FTES)
  - Asian Students: -7 percent (-40 FTES)

## Jurisdiction

- FTES enrollment at the Alexandria among students from the following jurisdictions in NOVA's service area experienced the greatest decline from Fall 2015 to Fall 2016:
  - Fairfax County: -16 percent (-173 FTES)
  - Alexandria City: -8 percent (-84 FTES)
  - Arlington County: -11 percent (-85 FTES)
