Point-in-Time Comparison (August 8, 2016 versus August 10, 2015) of FTES by Subgroups:

Annandale Campus

This Research Brief compares FTES enrollment at Annandale Campus disaggregated by student demographic subgroups in Fall 2015 and Fall 2016. The data in this document provide a point-in-time comparison: Monday, August 8, 2016 compared to Monday, August 10, 2015.

At the Annandale Campus, FTES declined by 5 percent (-348 FTES) from Fall 2015 to Fall 2016 as of August 8, 2016 (Table 1). The following is a summary of the trends among different student demographic sub-groups.

Age

- FTES among traditional age students (ages 18 to 21) at the Annandale Campus decreased by 2 percent (-101 FTES).
- Students in the following large age groups exhibited decreases greater than the overall campus decrease of 5 percent:
 - o 22-24: -6 percent (-72 FTES)
 - o 30-44: -8 percent (-60 FTES)

Gender

• The decrease in FTES from Fall 2015 to Fall 2016 at the Annandale Campus was 5 percent each for male (-177 FTES) and female students (-172 FTES).

Student Type

- FTES enrollment among first-time to college students at the Annandale Campus decreased by 7 percent (-105 FTES).
- FTES of returning students decreased by 4 percent (-215 FTES).

Race/Ethnicity

- Of note, at the Annandale Campus, the FTES of Black and Hispanic students declined very little from Fall 2015 to Fall 2016: about 1 percent each (-6 FTES and -13 FTES, respectively).
- However, there were notable decreases among the following large racial/ethnic groups:
 - White Students: -10 percent (-252 FTES)

¹ This data is a snapshot taken two weeks prior to the first day of classes and does not reflect final enrollment data for the semester.

o Asian Students: -5 percent (-90 FTES)

Jurisdiction

- The largest decline in FTES enrollment occurred among students from Fairfax County, a 6 percent decrease (-266 FTES).
- The Annandale Campus saw a slight gain in FTES among students from Alexandria City (3 percent, 21 FTES).
