Point-in-Time Comparison (August 8, 2016 versus August 10, 2015) of FTES by Subgroups: **Manassas Campus**

This Research Brief compares FTES enrollment at Manassas Campus disaggregated by student demographic subgroups in Fall 2015 and Fall 2016. The data in this document provide a point-in-time comparison: Monday, August 8, 2016 compared to Monday, August 10, 2015.1

The Manassas Campus showed almost no change in FTES in Fall 2016 compared to Fall 2015 as of August 8, 2016 (-0.1 percent, -3 FTES) (Table 1). The following is a summary of the trends among different student demographic sub-groups.

Age

- The largest age group of students at Manassas traditional age students ages 18 to 21 - also showed the largest decrease in FTES of any age group: -4 percent (-74 FTES).
- A notable increase in FTES occurred among students ages 30 to 44: 23 percent, or 58 FTES.

Gender

While FTES enrollment declined by 5 percent (-70 FTES) for male students, it increased by nearly the same amount (5 percent, 69 FTES) among female students.

Student Type

- FTES enrollment among returning and transfer students increased at the Manassas Campus:
 - Returning: 5 percent (103 FTES)
 - Transfer: 34 percent (50 FTES)
- However, there was an 18 percent decrease (-157 FTES) among first-time students.

Race/Ethnicity

- Among Asian students at the Manassas Campus, FTES enrollment increased considerably (13 percent, 53 FTES). FTES also increased among Black students by 5 percent (17 FTES).
- The largest decrease in FTES occurred among White students (-5 percent, -74 FTES), followed by Hispanic students (-6 percent, -29 FTES).

¹ This data is a snapshot taken two weeks prior to the first day of classes and does not reflect final enrollment data for the semester.

Jurisdiction

- FTES enrollment increased among students from several jurisdictions, including:
 - Alexandria City: 55 percent (11 FTES)
 - o Fairfax County: 2 percent (13 FTES)
 - Other Virginia Locations: 7 percent (17 FTES)
- Notable declines in FTES enrollment occurred among students from the following jurisdictions:
 - Manassas City: -4 percent (-28 FTES)
 - Prince William County: -2 percent (-22 FTES)
