Proposed 2017 Summer Sessions

Summer Sessions at NOVA offer a convenient and affordable opportunity for transient students from other colleges and universities and recent high school graduates to earn transfer credits during their summer semester.

To optimize local transient student and high school graduate Summer enrollment, NOVA should consider altering its Summer Sessions as follows:

- One 10-Week Session: May 22 to July 30
- Two 5-Week Sessions: May 22 to June 25 and June 26 to July 30
- One 8-Week Session: May 29 to July 23

This Policy Brief explains why this proposed schedule would help NOVA maximize Summer Session enrollment among transient students and local high school students.

Transient Students

For most four-year universities in the region, Spring semester final exams occur between May 5 and May 17 (Table 1). Thus, in order to target transient students from area universities, NOVA Summer Sessions should start May 21 or later. In 2016, however, most Summer classes began on May 16.

Local Public High School Graduates

In 2017, all Northern Virginia public high schools will end their classes by June 23 (Table 2). In order to target 2017 high school graduates, the later Summer Session should not start before June 26.

Comparison of NOVA Summer Sessions to Other VCCS Colleges

Table 3 presents Summer Sessions offered at VCCS colleges in 2015-16. NOVA is the only college in the Virginia Community College System (VCCS) that offers a 12-Week Summer Session. NOVA and Tidewater Community College are the only VCCS colleges that hold two 6-Week Summer Sessions. Instead, most VCCS colleges hold 10-Week Summer Sessions, and all but five VCCS colleges hold two 5-Week Summer Sessions.
