

ELIBIGIBILITY REQUIREMENTS

To be eligible for a Cooperative Education (Co-ops) and Internships for elective credit at NOVA, students must have already:

1. Declared a major (degree or certificate) at NOVA
2. Completed 15 college credits or the equivalent (transfer credits may be included)
3. Completed minimum of 6 credits (2 courses) at NOVA, directly related to the student's program of study and the co-op or internship position
4. Earned a cumulative GPA of 2.0 and 2.0 in major
5. Identified a sponsoring employer who agrees to offer them a co-op or coordinated internship opportunity
6. Completed any additional requirements identified by the corresponding Academic Department and Employer
7. Completed a "Co-op/Internship Registration Packet" and received authorization from the corresponding Academic Department and/or Internship Office.

INTERNATIONAL STUDENTS

Additional requirements for international students to be eligible for a paid Co-ops or Coordinated Internship course include that they must have:

1. Current F-1 status
2. Completed one **academic** year of full time study consisting of 2 semesters (30 credits), not including summers
3. Completed one semester of degree studies at NOVA
4. Internship credit that can be applied toward degree
5. Confirmation of eligibility for CRT Work Authorization (Internship Coordinator will confirm with Office of International Student Services, if above eligibility is met)

DID YOU KNOW?

1. Employers often require students to earn academic credit for their internships under U.S Department of Labor guidelines.
2. Some internship courses can be completed through distance learning technology and do not require classroom meetings, although periodic meetings with the instructor will be required.
3. Students may be eligible to receive a salary, stipend, or tuition assistance from employers, in addition to academic credit from NOVA.
4. The College Internship Coordinator will assist students in navigating the internship course application process and, in the case of eligible international students, assist in the process of obtaining CPT Work Authorization.
5. NOVA's internship for credit courses help fulfill workplace requirements that require students to earn college credit for their internships.
