

## F-1 Student Financial Statement – Associate Degree

Instructions: As a student, it is your responsibility to demonstrate that you will have sufficient financial support available to cover all educational and living expenses while you are studying at NOVA. Completing an associate degree may take up to 3 years. You must show the promise of funding for up to three years. In addition to a promise of funds for 3 years, you must provide bank statements to show that the money for at least the first year is presently in a bank.

If you are self-funded you must show money in the bank for 3 years or explain how you will obtain these funds, given that you cannot be employed in the U.S

Please make a copy of all financial documents before sending them to NOVA. You will need copies of these documents when you apply for your F-1 visa or F-1 status.

All bank statements must be in English, be a certified English translation or clearly show the account owner's name, statement date, balance and type of currency. (NOVA reserves the right to request clarification or additional information related to bank statements)

\* To maintain F1 status a student must take at least 12 credits in the fall and spring semester. However, students are strongly encouraged to take more than 12 credits each semester.

\*\* Estimated living costs are only for the nine month academic year. Students who intend to remain in the US in summer should plan for additional costs.

Dependent Expenses: If you will be accompanied by dependents (spouse and/or child) you must add \$6,898 per year of support for a spouse and \$3,450 for each child.

SPONSOR'S AFFIDAVIT OF SUPPORT

A sponsor may be a parent, family member, or another person who will provide financial support. It is not necessary that a financial sponsor live in the U.S. If there is more than one sponsor, please make a copy of this document for each sponsor to complete. One financial sponsor may provide complete or partial support for the student, but the student's total financial support must equal or exceed the total estimated costs (see page 1).

**To the financial sponsor:** In addition to signing this document, you must provide a **bank statement** that includes your name, the name of your bank, the statement date, amount of the available funds and type of currency. The bank statement must be in English, be a certified English translation or clearly show the information required. **The statement must be recent (dated not more than six months before the date classes will begin at NOVA).**

**This evidence is required to complete an official US government form on which the school official is confirming that financial support is available. Therefore, Northern Virginia Community College reserves the right to request additional information or clarification.**
