

F-1 Student Financial Statement – Intensive English Program

Instructions: As a student, it is your responsibility to demonstrate that you will have sufficient financial support available to cover all educational and living expenses while you are studying at NOVA. You must show a promise of funds and you must provide bank statements to show that the promised money is presently in a bank.

Please make a copy of all financial documents before sending them to NOVA. You will need copies of these documents when you apply for your F-1 visa or F-1 status.

All bank statements must be in English, be a certified English translation or clearly show the account owner’s name, statement date, balance and type of currency. (NOVA reserves the right to request clarification or additional information related to bank statements)

SPONSOR'S AFFIDAVIT OF SUPPORT

A sponsor may be a parent, family member, or another person who will provide financial support.
