

## F-1 Student Financial Statement – Intensive English Program

**Instructions:** As a student, it is your responsibility to demonstrate that you will have sufficient financial support available to cover all educational and living expenses while you are studying at NOVA. Completing an associate degree may take up to 3 years.

If you have a sponsor or sponsors who will be funding your studies, you must provide bank statement(s) to show estimated costs below for the year. Or, if you are self-funding your studies, you will need to show money in your personal bank statement for the full year.

All bank statements must be in English, be a certified English translation or clearly show the account owner’s name, statement date, balance and type of currency. (NOVA reserves the right to request clarification or additional information related to bank statements)

Make a copy of all financial documents before sending them to NOVA. You will need these documents when you apply for your F-1 visa.

**Tuition:** Rates are subject to change without notice. Tuition amount is based on the equivalent of 12 credits per semester. IEP courses are offered as Continuing Education Units (CEUs) which are non-credit courses.

**Housing:** NOVA does not offer housing. You will be responsible for making your own living arrangements. Living expenses are estimated.

**Dependents:** If bringing your spouse and/or child you must add \$6,898 per year of support for a spouse and \$3,450 for each child.

## SPONSOR'S AFFIDAVIT OF SUPPORT

A sponsor may be a parent, family member, or another person who will provide financial support. It is not necessary that a financial sponsor live in the U.S. If there is more than one sponsor, each sponsor must fill out a separate Financial Statement form. One financial sponsor may provide complete or partial support for the student, but the student's total financial support must equal or exceed the total estimated annual costs (see page 1).

**To the financial sponsor:** In addition to signing this document, you must provide a bank statement that includes your name, the name of your bank, the statement date, amount of the available funds and type of currency. The bank statement must be in English or be a certified English translation that clearly shows the information required. **The statement must be dated no more than six months before the semester start date the applicant is applying to study at NOVA.**

This evidence is required to complete an official US government form on which the NOVA school official is confirming that financial support is available to support the students' studies while living in the U.S. Therefore, Northern Virginia Community College reserves the right to request additional information or clarification if necessary.
