



minutes to prepare for returning to NOVA!

1. Do I need to wear a face covering?

Yes! Everyone at NOVA is required to wear a face covering while on campus. This includes indoors and outdoors, and when 6 feet of physical distancing cannot be maintained. Employees with conditions that prohibit face coverings should contact the College ADA office by clicking [here](#) and students should contact Disability Support Services [here](#). 2. Are sanitizing supplies being provided in my classroom?

Yes! NOVA has provided hygiene stations in all areas that will be used for the fall semester. These include classrooms, libraries, and open computer labs. Grab a few wipes and sanitize your space! Hand sanitizer is also provided at these stations.

3. Is the College actively sanitizing spaces for use?

Yes! The College is currently utilizing daily enhanced cleaning in all spaces. This includes sanitizing frequently touched items such as door knobs and handrails.

4. Can I come to campus if I am not feeling well?

No! NOVA recommends that you stay home if you are not feeling well and contact your doctor. You should also notify your instructors or supervisor if you are not feeling well. We want everyone to be in their best Nighthawk condition before returning to campus.

5. Should I check my health conditions before coming to NOVA?

Yes! NOVA has partnered with GoCanvas to provide a health screening application for your mobile device to make daily screening easier! Instructions to download and use the GoCanvas app can be found [here](#).

6. Who do I notify if I receive a positive result from a COVID-19 test?

If you want to share your test results with NOVA, please email your name, phone number, and the last places you were at on NOVA property to us [here](#) if you have been on campus in the last 14 days.

7. What services is NOVA offering and what times are these offices open?

NOVA is limiting days and times for in-person services provided during the fall semester. Some of the services that will be available in-person are parking, business offices, and bookstores. Services offered and hours of operation are listed [here](#).

8. Does NOVA have a Return to Campus Plan and was it approved?

Yes! NOVA developed a Return to Campus Plan for reopening during the fall semester. The plan was approved by the State Council of Higher Education for Virginia and can be found [here](#).

9. Is there training that is required before I return to campus?

Yes! You should find an assignment on your Canvas dashboard that must be completed before you return to campus. The assignment includes COVID safety information, a short anti-stigma video, and a NOVA pledge to keep ourselves and each other safe while on campus.

10. Can I remain on campus after my class?

No! Faculty and students are asked to not linger on campus after class, avoid gatherings or groups, and leave NOVA as soon as possible after class.
